Applications received after the above mentioned date will under no circumstances be entertained. Information sent through Signal/FAX will not be considered till the receipt of post copy along with prescribed proforma by due date. Candidates may be asked to put the chance in remarks column against which they are going to appear this time.

In pursuance of guidelines notified vide Ministry of Social Justice and Empowerment, Deptt of Disability Affairs, New Delhi OM No. 16-110/2003-DD.III dated 26/02/2013 details of the physically handicapped category of the candidates may be intimated. In this context, please refer to this office letter No. AN/IC/SAS-II/NS/September/2013 dated 21/8/2013 vide which detailed guidelines issued by HQrs office vide their No. AN/SAS/16100/ph/Guidelines dated 12/08/2013 were circulated for PH candidates. It is further reiterated that if any physically handicapped candidate desirous of availing facility of scribe/compensation time etc. as per Min. of Social Justice and Empowerment, Deptt of Disability Affairs, New Delhi OM dated 26/02/2013 may apply along with requisite medical certificate, well in advance preferably before 20th August, 2014 so that it can be forwarded to HQrs office for consideration of their request by the Competent Authority.
