Ref :- This Office letter No.Pay/Tech/Clf/XVI dated 07/09/2018

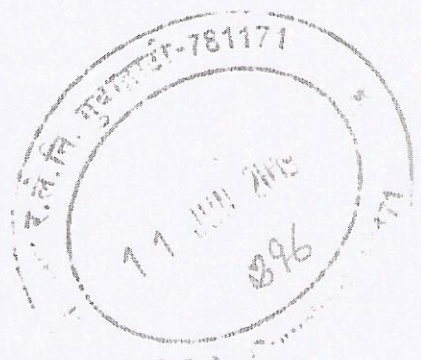
Please refer to this office letter of even No. dated 07/09/2018 (copy enclosed) under which information regarding practice being adopted under your organization for admissibility of various allowances i.e. SDA, RLA etc. to Casual Workers with Temporary Status was requested from your office but the same has not been received as yet.

Civilian employees serving in different units at Leh which is a hard station are entitled of SDA/RLA/TPT at this station. A doubt has arisen as to whether casual labour with temporary status are also entitled of ibid allowance viz SDA/RLA/TPT while serving at leh. However, this office is unable to lay its hands on such specific orders under which such allowances to be admitted.

In view of the above, you are requested to forward practice being followed in your Command alongwith a copy of the appropriate Government letter/Authority, if any, under which such allowances are to be admitted.
