2. Any correction thereto, if necessary, in regard to the name(s) of the candidates /Account No. /Centre etc, if wrongly notified in the enclosed statements may be intimated for correction.

3. As per SAS Rule 14(b), each permission to appear in SAS Part I or Part-II examination will count as one chance against the respective part, whether he/she actually sits for the examination or not unless he/she is specially allowed to withdraw his/her name by the CGDA. In accordance with the ibid proviso read with SAS Rule 14(d) withdrawal of the candidate not submitted within laid down time period would count as a chance. It may be clarified that as per decision of MoD (Fin), withdrawal of a candidate of medical ground was removed when the scheme of examination was revised during 2007. As such failure to appear in this examination by way of absenteeism on Medical ground and request submitted after time limit specified in SAS Rules will entail forfeiture of one of the four valuable chances allowed to candidates as per revised SAS Rules. It is clarified that under no circumstances request for withdrawal in respect of candidates availing special chance will be accepted.

4. Further in order to ensure transparency and fair conduct of Examination, the Competent Authority has decided to Video-graph (with audio) the entire proceedings of the Examination during all the Five Papers. This may please be brought to the notice of all candidates.

5. The signature of each candidate (including those who are on Leave) may be obtained in token of having noted the contents of this Part-II O.O. and kept in record.
