As per SAS Rule 4, to be eligible for appearing in the Preliminary Test to SAS Part-I examination, A candidate must have put two years service as on the first of the month in which examination is held (including continuous temporary service) in any of the grade Sr. Auditors / Auditors/ Clerks/ Typists/ DEOs/ Stenographers/Hindi Translators and Librarians in the Department provided that candidate must have cleared probation period. Thus, due to rescheduling of examination, the cut of date for counting two years of service will now be **1st June, 2014**. The other conditions notified this office even letter dated 27/01/2014 remains unchanged.

A candidate who fulfills the revised criteria stipulated above may apply for appearing in Preliminary Examination (Test) to be held on 10th June, 2014 by FAX/email.
