

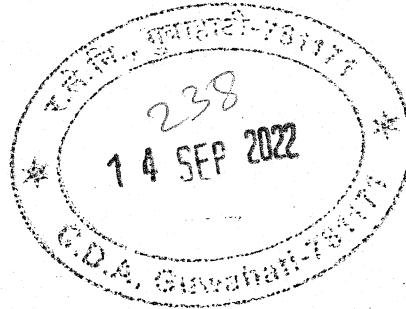



No. HMA-19015/9/2019-Political(A)/120 :: Whereas, the Government of Assam in exercise of powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 (Act 28 of 1958) had declared the entire state of Assam as "Disturbed Area" vide notification No.HMA-19015/9/2019-POLITICAL(A)/102, dated 28/02/2022 with effect from 28/02/2022 for a further period of 6 (six) months;

Whereas, a review of the law and order and security scenario in Assam in the recent past indicates that the situation has considerably improved in many districts of the State and the presence of extremist elements are confined to only in certain parts of the State;

Now, therefore, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No.HMA-19015/9/2019-POLITICAL(A)/102, dated 28/02/2022, the Governor of Assam is pleased to withdraw the declaration of "Disturbed Area" w.e.f. 01.04.2022 from 23 (Twenty Three) districts and 1 (One) Sub-division of the state viz. (1) Dhemaji (2) Lakhimpur (3) Majuli (4) Biswanath (5) Sonitpur (6) Nagaon (7) Hojai (8) Morigaon (9) Kamrup Metro (10) Darrang (11) Kamrup (12) Nalbari (13) Barpeta (14) Goalpara (15) Bongaigaon (16) Dhubri (17) South- Salmara Mancachar (18) Kokrajhar (19) Chirang (20) Baksa (21) Udalguri (22) Karimganj (23) Hailakandi and (24) Cachar district except Lakhipur Sub-division.

Further, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No.HMA-19015/9/2019-POLITICAL(A)/102, dated 28/02/2022, the Governor of Assam is pleased to **declare** the areas covering 9 (Nine) districts and 1 (One) Sub-division viz. (1) Tinsukia (2) Dibrugarh (3) Charaideo (4) Sivasagar (5) Jorhat (6) Golaghat (7) Karbi Anglong (8) West Karbi Anglong (9) Dima Hasao and (10) Lakhipur Sub Division of Cachar district of the State of Assam as "Disturbed Area" for a further period of 6 (six) months w.e.f. 01/04/2022, unless withdrawn earlier.
