Please refer to above communication under which it was requested that necessary instructions may be issued to all AAO BSO/AO GE dealing with revenue matters to strictly adhere to the prescribed time schedule in raising the bills of rent and allied charges of all married accommodations/quarters/buildings.

2. In this context, it has brought to notice of HQrs office by AFCAO Subroto Park, New Delhi that rent and allied charges in respect of Airmen/NC(E) are being received late ranging from 2 months to 5½ years which results in inordinate delay in recovery and immense hardship to the Air Warriors.

3. In view of the above, it is again reiterated that AAO BSO/ AO GE offices under audit jurisdiction of your office may suitably be instructed in this regard and it may be ensured in that rent bills are being issued as per prescribed time schedule.
