The delegation of power made vide ibid Paras have been reviewed and following provision is made in addition to the provisions which already exists:

In a situation wherein Jt. CDA/Addl. CDA is not positioned in a field office, the Group Officers i.e ACDA/DCDA may be delegated the powers of signing of PM in 1/0 transfer adjustments and rectification of incorrect adjustment upto Rs.10 crore and Rs.5 crore respectively.
