

Subject : Coverage of Central Government employees under Central Civil Services (Pension) Rules, 1972 in place of National Pension System

Vide DoP&PW's OM No. 57/04/2019 P&PW(B) dated 17.02.2020 (which had been circulated vide this HQrs office's letter no. AN/XIV/14143/NPS/DAD/Vol.II dated 25.02.2020) the benefit of old Pension Scheme had been extended in all such cases where the selection process (including written examination, interview and declaration of the result) for recruitment had been completed before 01.01.2004 but the employee joined the Govt. service on or after 01.01.2004 subject to exercising of one time option to be covered under CCS (Pension) Rules, 1972.

2. In this regard, attention is invited to Para 9 of the ibid DoP&PW OM lays down that the Government servants who exercise option to switch over to the pension scheme under CCS (Pension) Rules, 1972 shall be required to subscribe to the GPF. Further, guidelines as stipulated vide CGA's letter No. 1(7)(2)/2010/cla./TA.III/390 dated 14.11.2019 for accountal of corpus in NPS account of the subscriber had been reproduced thereunder.

→ 3. For ensuring seamless transition, it is enjoined upon all offices to process the requests for transfer of NPS accumulation to Government account strictly in accordance with guidelines as stipulated in ibid DoP&PW OM. In addition, the following information may be furnished to this HQrs office by 20.01.2020 for further necessary action in the matter:

- (i) How many employees gave option within the stipulated date.
- (ii) How many of them were found eligible.
- (iii) How many employees gave option after the stipulated date and were found eligible.
- (iv) Number of applications pending decision if any, after the stipulated time.
