A condemned government vehicle as per details given below has been declared for disposal through Public Auction in terms of Rule 220 of General Financial Rules 2017 applicable in Central Government Department.

Terms and Conditions:

- i. GST rates as applicable on the date shall be payable by the successful bidders over and above the accepted quote.
- ii. Acceptance or rejection of a bid should be announced immediately on the stroke of the hammer. If a bid is accepted, earnest money (twenty-five per cent. of the bid value) should immediately be taken on the spot from the successful bidder.
- iii. The vehicles will be disposed off on "as is where is" basis and no guarantee for its worthiness or quality will be given by this office.
- iv. Delivery has to be taken within 7 (Seven) calendar days (called free delivery period) from the date of the acceptance letter/sale order (excluding the date of issue of acceptance letter/ sale order). The delivery of vehicle will be given only after realization of the demand draft/ pay order. If the purchaser is not able to lift the vehicle within the free delivery period, he may request for an extension. Such extensions will be granted after levying a ground rent @ 1/2 (half) per cent of the sale value per day.
- v. The seller will not be, in any way, responsible for failure to deliver the vehicle due to causes beyond his control such as a strike, lockout, cessation of work by labourers, shortened hours, act of God or other causes or other contingencies whatsoever. The buyer shall not be entitled to cancel the contract and the period of delivery shall automatically be extended proportionately.
- vi. Vehicle sold but not removed within the specified date will become the property of the seller and it will have the right to dispose of vehicle in any manner as he deems fit without any notice.
- vii. **Witnessing Delivery**
Vehicle sold shall be weighed or counted before delivery, this being supervised by the:
 - i) CDA Guwahati representative;
 - ii) Representative of the purchaser (if he wants to be present).

viii. The vehicle will be delivered only after the receipt of full payment and after the successful bidder submits documentary evidence in support of residential status viz. Ration card/Voter ID card/Passport in case of individual and Registration Certificate in case of firms etc. The sold



ix. The successful bidder will also be responsible for getting the Registration Certificates of the vehicles transferred in his name (if/as necessary/required by law) at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

x. All the bidders undertake to abide by the additional terms and conditions (if any) as would be laid down by the competent authority from time to time.

xi. The CDA Guwahati reserves the right to accept or reject any or all the bids without assigning any reasons whatsoever. The decision of the CDA Guwahati will be final in this regard during the process of this Bid-cum Sale at any stage.

xii. The bid of the highest acceptable responsive bidder shall normally be accepted and an acceptance/sale order be issued. However, if the price offered by that bidder is not acceptable, a negotiation may be held only with that bidder.
