- ii. Acceptance or rejection of a bid should be announced immediately on the stroke of the hammer. If a bid is accepted, earnest money (twenty-five per cent. of the bid value) should immediately be taken on the spot from the successful bidder.
- iii. The goods will be disposed off on "as is where is" basis and no guarantee for its worthiness or quality will be given by this office.
- Delivery has to be taken within 7 (Seven) calendar days (called free delivery period) from the date of the acceptance letter/sale order (excluding the date of issue of acceptance letter/ sale order). The delivery of material will be given only after realization of the demand draft/ pay order.
