As you are aware that HQrs office vide letter dated 2/2/2015 & 19/7/2016 had already issued necessary instruction for placing a system of liaison officers in all PCsDA/CsDA to ensure speedy and authenticated flow of allocation letter to come into effect in the 4th Quarter of the financial year alongwith the RE.
