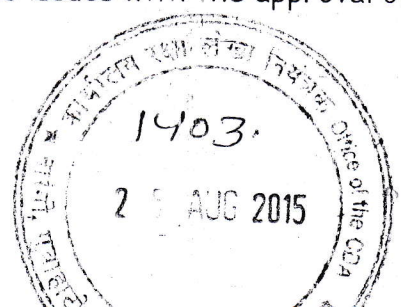
Sub :- Metering of Electricity Consumption for paying & non paying consumers in Defence.

It has brought to the notice of HQrs office that electric bills in respect of paying & non paying consumers in defence are not being regularly issued by MES or charged at flat rates, much lower than actual consumption resulting in huge revenue loss to Govt. Non recovery of electricity charges on the basis of meters is a serious issue as flat rates will be very low. This needs to be looked at for all the stations under your audit jurisdiction. It is requested to furnish the following information to this HQrs office for further appreciation of the subject matter :

- i) Total number of AAO BSO under audit jurisdiction of your office or AO GEs entrusted with revenue work.
- ii) Total number of Quarters/buildings under each AAO BSO/AO GE.
- iii) Periodicity of return of recoveries in r/o Electricity charges i.e. monthly or quarterly.
- iv) Whether electricity charges are charged at flat rate or actual consumption.
- v) In case charged at flat rates, reasons thereof and action taken with executive authorities.
- vi) Number of cases in r/o PBORs wherein no billing is being done on the pretext of free consumers.

2. The information on the above points may please be provided to HQrs office at the earliest.
