I am writing this in connection with non-receipt of vacation reports from the AOGEs/AAOBSOs falling under the audit jurisdiction of your office. In this regard, please refer to this office letters bearing no. Rent Cell/Insp/Vacation Report, dt. 12/07/2019 and 18/11/2019.

While some of vacation reports have been submitted by the concerned offices, in 12 cases, the vacation reports are still awaited. A list of the same is enclosed as Annexure-I. Due to non-receipt of vacation reports, rent recovery for two quarters is being made. In this connection I would like to mention that these cases have been objected by HQ Office during their inspection.

A list of wanting vacation reports identified by this office is also enclosed as Annexure-II. Non receipt of vacation reports has also resulted in numerous complaints from Army Officers on double recovery and requests for refund of excess recovery. However, in the absence of vacation reports, this office is unable to take action on Officer's complaints.

I would therefore, request you to look into the matter personally and direct the concerned offices to submit the vacation reports through "PROJECT BHAVAN" on priority.
