Subject: **Implementation of SBI CMP in AOs GE/AGE(I)/CCE Offices.**

It has been instructed by HQr Office to implement SBI CMP in all the AOs GE/AGE(I)/CCE offices under the administrative control of CDA Guwahati.

In this connection, a Training Cum Workshop on implementation of SBI CMP in AOs GE/AGE(I)/CCE offices was also conducted on 10/01/2020 in Main office CDA Guwahati under the Chairmanship of Hon'ble Controller to educate the AOs GE/AGE(I)/CCE regarding various processes involved in implementation of SBI CMP.

During the Conference, it was categorically directed by Hon'ble Controller that all AOs GE/AGE(I)/CCE will implement SBI CMP in their respective offices by January 2020, but till date no completion/ feedback report has been received from various AOs GE/AGE(I)/CCE offices.


Non-implementation of SBI CMP in all the AOs GE/AGE(I)/CCE offices under the administrative control of CDA Guwahati has been adversely commented upon by HQr office. Such a lackadaisical attitude on the part of AOs GE/AGE(I)/CCE has also been viewed seriously by the CGDA Office.

In this connection, it may be noted that no Cash Assignment will be released in favour of GEs/AGE(I)s/CCEs by this office.

It is, therefore, impressed upon that failure of releasing payments to the parties concerned due to non implementation of SBI CMP vis-à-vis for want of Cash Assignment will be the personal responsibility of the AOs GE/AGE(I)/CCE.

In view of the above, the undersigned has been directed by the Competent authority to instruct you to implement SBI CMP in your respective offices (if not yet implemented) immediately and forward a completion/ feedback report by 20/02/2020 positively. In case of any problem faced during implementation of SBI CMP, same may be brought to the notice of M.O immediately.
