Please find enclosed herewith a copy of HQ. CGDA New Delhi Cantt Most Important Circular No. AT/IX/9504/GST dated 16/06/2017 which is self explanatory. Since Section-24 of CGST Act requires mandatory registration for certain categories of department/persons/firm, including: (vi) persons who are required to deduct tax under section 51. As such, all DDOs are advised to register for TDS of GST before 1st July 2017.

Further, it is requested to disseminate the same to all offices who are acting as a DDO's under the audit jurisdiction of your office for compliance of the same.

Most Important Circular

To,

All PCsDA/CsDA

<u>Sub</u>: Implementation of GST by DAD.

With the 101st Constitution Amendment Act coming into force on 8th Sept 2016 and notification of the GST Council on 15th September - the road to GST rollout is clear. Government is keen on introduction GST the biggest indirect tax reform, with from 01 July 2017.

- 2. Section-24 of the CGST Act requires mandatory registration for certain categories of department/ persons/ firm, including: (vi) persons who are required to deduct tax under section 51, whether or not separately registered under this Act. DDOs thus need to get registered in GST using their TAN Number using form GSTR REG-07.
- 3. Registration of DDO has to be done State wise. Therefore, PCsDA/ CsDA having trans-State jurisdiction would have to register in each State separately.
- 4. All DDOs are advised to register for TDS of GST before 1st July 2017. The form for this purpose is available on CBEC Website.
