

2. The matter has been examined and it is observed that there appears to be an obvious duplication where two DAD entities are checking the LPC Cum Data Sheet. This can be resolved by revising procedure to ensure that Data Sheet is checked only by PAO with respect to Service Book audited by LAO.

3. In view of above, it is intimated that the instruction earlier issued in this regard may please be revised. Instructions may also be issued to the PAOs for taking necessary action.

4. All previous instructions issued by the CGDA HQrs on the subject matter stand modified to the above extent.
