


Thematic Audit on 'Court of Inquiry' in the Indian Army.

It is intimated by the DGADS, New Delhi vide their letter cited under reference that under the instruction of C&AG, their office was asked to conduct an Audit on the topic 'Court of Inquire' in the Indian Army. In this context, the team auditing HQ Eastern Command has examined 54 financial loss cases (as per enclosures), where Court of Inquiry was conducted.

In this regard, DGADS, New Delhi is requested that the following information/documents may please be furnished to audit at the earliest in respect of these 54 cases.

- 1. The date of reporting of these cases to PCDA/CDA/AO/LAO along with supporting documents.
- 2. Details of action taken by OCDA/CDA/AO/LAO, if any.
- 3. Details of information furnished to Statutory Auditors i.e. o/o the DGADS/DADS in respect of these financial losses.
- 4. Details of any other financial loss reported by Army authorities under the AOR of HQ Eastern Command, apart from these 54 cases.

In this concern, it is requested that the aforesaid information may please be furnished to this office by 11.04.2022 for timely submission to DGADS, New Delhi.
