Subject: Revision of flat rate of license fee for Service Officers & Defence Civilians.


It has come to the notice of this office that some AO GEs/AAO BSOs are recovering full rate of licence fee as per GoI Ministry of Urban Development, Directorate of Estates order meant for 'General Pool Residential Accommodation (GPRA)' instead of flat rate of licence fee issued by the Ministry of Defence, resulting double recovery of license fee from Service officers/Defence civilians occupying the accommodation of MES/Defence pool accommodation.

Examination of the issue further revealed that notifications for license fee are being issued from time to time by GOI, Ministry of Housing and Urban Affairs, Directorate of Estates for **General Pool Residential Accommodation (GPRA)** throughout the country whereas for **Defence Service Officers and Defence Civilians order** for flat rates of licence fee is issued by the Ministry of Defence time to time.

In this connection, latest order of GoI, Ministry of Defence bearing letter no. 1(1)/2014-D(Q&C) Dt. 01.07.2022 issued subsequent to GoI, Ministry of Urban Development, Directorate of Estates OM No. 18011/2/2015-Pol.III Dt. 29.06.2020 regarding revision of flat rates of licence fee for residential accommodation in r/o Service Officers & Defence Civilians effective from 01.07.2020 is enclosed herewith for necessary action.

In view of the above, it may be ensured at your end that the latest revision issued by the **Ministry of Defence** be taken into account while recovering the revised license fee from the occupants of residential accommodations **with effect from 01.07.2020**.

A confirmation in this regard along with a copy of L/F bill in r/o Service Officers may be furnished by 30/12/2022.


