Subject: Monitoring of Defence Pension Budget Leave Encashment- Code Head 00/014/63 (Army), 00/014/64(Navy) & 00/014/65 (Air Force).

On review of compiled actual up to the month of 11/2018, it is observed that various sub-Offices have booked 60,66,26,686.00 under the head Leave encashment, (Army) Code Head 00/014/63 and 189,49,449.00 under the head Leave Encashment, (Air Force) Code Head 00/014/65 against the overall projected RE 2018-19 amounting to 94,58,83,336.00 (Army) and 2,49,42,970.00 (Air Force) respectively. The details of booking made by various sub offices up to the Month of 11/2018 against their projected RE 2018-19 are furnished as Annexure -"A". It would be seen from the sub Office -wise booking details that in a number of cases actual booking up to 11/2018 are either much higher or less compared to RE amount projected by them. In some cases, it is observed that either the concerned sub-Offices did not project any RE. As a result, their booking of expenditure stand incurred without allotment of fund which is highly irregular. It is pointed out that AO GE (AF) Jorhat has been compiled the expenditure for Rs. 21,20,152/= against the RE amount of Rs. 1,27,386/= which is abnormally high and requires clarification at the earliest.

Hence it is, advised/requested to review your requirement vis-a-vis booking made till November 2018 and ensure that no excess/less booking is made against the allotment during the year 2018-19. In case, it is expected that a portion of the allotment will not be utilized during the year 2018-19 and is required to be surrendered, the same may please intimated to this office in due course of time. Similarly, the additional

requirement over and above the amount projected for the year 2018-19 may also be intimated to this office for submission of consolidated requirement to the PCDA (P) Allahabad for inclusion in the modified appropriation. The reasons for surrender/additional requirement, if any, during 2018-19 may also be intimated for submission to the PCDA (P) Allahabad.

The above information may please be sent, by FAX/email, so as to reach M.O. latest by <u>07/01/2019</u> positively to enable this office to submit the Consolidated Report to PCDA(P) Allahabad within the stipulated time. The Officer -in-Charge will be personally responsible for any excess expenditure over the RE amount or less booking projected against the RE amount by them during the F.Y. 2018-19 (including the present additional requirement/surrender, if any).

NIL report is also required.
