



After issuance of MOD ID under reference on the above subject which was circulated vide this HQrs office letter dated 02.08.2017, this HQrs office started receiving various reference as to who is the competent authority to issue of One-Time office order for admittance of Night Duty Allowance (NDA). The issue has been examined at this HQrs office taking the ibid MOD ID into the consideration and views obtained from various controllers. The competent authority is of the view that mentioning of the statement in para 6 of MOD ID dated 07.07.2017 **"till such time the new pay parameters based on the current pay structure to determine the entitlement for NDA are prescribed by the nodal Ministry, OFB/Field Offices/Defence Establishments are allowed to determine the entitlement of their employees for the purpose of NDA in terms of this clause in the DoPT OM dated 04.10.1989."** allows Commandants/OCs/COs of the units to issue One-Time office order for admittance of Night Duty Allowance for employees posted in his unit.

As such, the Night Duty Allowance may be admitted accordingly, subject to the fulfilment of other conditions as mentioned in MOD ID dated 07.07.2017.
