



It has been decided by the Competent Authority to call for volunteers amongst SAOs/AOs who fulfil the criteria listed below, for posting to AO 19 BRTF, Phuentsholing, Bhutan -


- (i) The applicant should not have served an earlier tenure in foreign posting.
- (ii) The applicant should have earned minimum grading of Very Good (VG) in APARs of last five years.
- (iii) No disciplinary / criminal case should be pending against the applicant and the officer shouldn't have been awarded any penalty (including warning) at any period of time in his / her carrier.
- (iv) Working knowledge of computer is desirable.
- (v) Working experience of MES/ BR is desirable (not mandatory).
- (vi) The applicant should have left with minimum 03 (Three) years of service as on 01st January, 2023.
- (vii) The applicant should not due for promotion to JTS of IDAS in the next 02 years.
