No such request of ex post facto permission without valid justification of severe emergency will be entertained at this end.

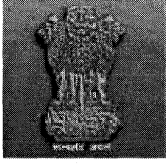


