It has been decided by HQrs Office cited under reference to invite option for choice stations for posting on promotion from amongst the AAOs belonging to unreserved category upto **Roster No. 900 (New seniority roster of AAOs)** and for AAOs belonging to reserved category (SC & ST) upto **Roster No. 1800** as per the Roster of AAOs circulated vide HQrs Office No. AN/IX/11056/roster Corr/2019 dated 13/05/2020. AAOs belonging to reserved category may also provide a certificate as per the provisions contained in DoP&T OM No. 36011/3/2005-Estt(Res) dated 09/09/2005 and HQrs Office circular No. AN/II/2151/PC-1089(N) dt 11/01/2013 (Undertaking enclosed).

The AAOs bearing eligible Roster Nos. and listed criteria may therefore, may submit their representations for posting to their choice stations citing reasons for request (duly supported with documents viz. medical certificate etc.), if so desired.


It is intimated that the posting will be decided after duly considering the information supplied and, therefore, no further representation for change of posting will normally be entertained once the promotion orders are issued by the HQrs, unless the request is for forgoing the promotion. No further representation for change of posting on promotion should, therefore, be forwarded unless it is for forgoing promotion or warranted by some unforeseen later developments.

Further, it is mentioned that circumstances of the eligible AAOs, earlier preferred their requests may have changed and therefore, fresh applications are required to be submitted to the HQrs. Office so that while deciding their postings, the latest position mentioned by them be kept in view for considering their posting on promotion to AO's grade.

The representation/requests must reach this section/office latest by **14/02/2022 positively** for onward transmission to HQrs. Office in time.


