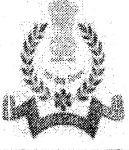

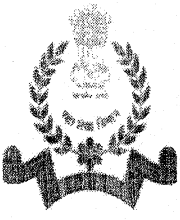
Subject: Implementation of P&C portal in AO GE Offices-reg.

A meeting on "Payment & Compilation portal" and other AT related issues was held with Regional Controller Offices through VC on 31.10.2022 at 04:00 PM under the chairmanship of Addl.CGDA (SGD).

The chair person welcomed all the members present in the meeting.

During the meeting, status of WAN connectivity in AO GE offices and implementation of P&C portal by AO GE offices was discussed with Controller offices. The PCDA/CDA wise status is enclosed herewith.

Issues being faced by Controller offices regarding implementation of P&C portal at various AO GE offices and directions of Addl.CGDA for implementation of P&C portal by 30th Nov 2022 are as under:

- (i) Some AO GEs are looking after more than one office. On P&C portal only one AO can be mapped to one GE at present. The Chair directed IT Wing to take this up with the development team to resolve the issue at the earliest.
(Action: IT Wing)
- (ii) Controllers stated that at some places WAN is not working properly. The Chair directed IT division this matter needs to take up with BSNL for the proper working of WAN. He further advised that wherever Work Order has been placed on BSNL for WAN connectivity, Controllers should take necessary follow up action with their sub offices to get BSNL to implement the Work Orders immediately. (Action: PCDA/CDA offices & IT Wing)
- (iii) The Chair also directed IT Wing to forward an updated Controller wise list showing AO GE offices for which Work Orders have been placed to BSNL for WAN connectivity to Controller offices for facilitate follow up with the BSNL.
(Action: IT Wing)
- (iv) The Chair reiterated that the portal is a part of PRABAL project and is being monitored at the highest level by the Ministry of Defence. All the Controllers should categorically instruct their AO GE offices that wherever WAN connectivity is available, they will mandatorily have to on-board on P&C portal and ensure that all payments should be made through P&C portal only. Further, wherever the orders have been placed for WAN (list will follow shortly from IT division of HQrs office) the same may be pursued to finality.
