HQ CGDA Office vide letter cited under reference has intimated that 1661 Nos. of PRANs against **Defence** has been identified by PFRDA as being "NIL CREDIT PRANs" i.e PRANs which have not received a single NPS Contribution since the date of their generation. Reasons for such PRANs may be Non-uploading of SCF/Generation of a second PRAN for an employee and has advised this office to take action on Priority for identifying and deactivating funding of all Nil Credit PRANs to avoid payment of maintenance charges on such redundant PRANs . Further , a Monthly progress report on the Subject has also been introduced wef March 2021 to be furnished to HQ Office by the first week of succeeding month.

In this Context, it is advised that necessary action may be taken for identifying such NIL CREDIT PRANs under your respective PAO jurisdiction inter alia if uploading has been done in any such PRAN then the timely remittance of contribution has to be ensured for all Subscribers. Further ,the progress of same is to be reported to this Office (DDP Cell) on Monthly basis in the enclosed proforma positively by the 5<sup>th</sup> of the succeeding month **through mail** for our further consolidation and rendition of same to HQ office.
