2. Vide this HQrs office's above cited letter dated 31-01-2020 it had been requested that DBT of pay & allowances of all defence civilians under your office's audit jurisdiction may be fully implemented w.e.f. 01-04-2020. As against this, it is observed from the latest report on the subject submitted by your office that such implementation is yet to be completed.

3. Accordingly, I would again request you to take further necessary action for ensuring full implementation of DBT of pay and allowances of defence civilians (through Tulip System) at the earliest. Further, a fortnightly report on progress made in this regard may be forwarded to HQrs Office through the e-Suchna portal in the format annexed with this letter.

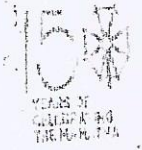

As per this HQrs Office letters cited above, it was requested to take preparatory measures for implementation of the modified TULIP in your office for direct credit of pay and allowances to the individual bank accounts of defence civilians including collecting the bank mandates from the concerned units.

2. In this regard it has been intimated by CDA, Secunderabad that the pilot project of direct payment of pay and allowances of defence civilians, of 3533 defence civilians of 83 units under the audit jurisdiction of CDA Secunderabad has been successfully completed in the month of September 2019. CGDA has desired that the DBT payment for all defence civilians' pay and allowances may completely be implemented by Dec 2019.

3. In view, the DBT payment for all defence civilians' pay and allowances under the payment jurisdiction of your office may be completed by Dec 2019.

3. Necessary action may be ensured immediately on Priority. Moreover, a monthly progressive report may be furnished positively by 5th of every month indicating the status of DBT payment for all defence civilians' pay and allowances in r/o the preceding month under your audit jurisdiction starting from 5th of November, 2019.

As per this HQrs Office letters cited above, the decision of the competent authority on the above subject was conveyed to your office and it was requested to ensure necessary action for implementation of the modified TULIP in your office by December, 2019 for direct credit of pay and allowances to the individual bank accounts of defence civilians.

2. It was also requested to furnish a monthly progressive report by 5th of every month indicating the status of DBT payment for all defence civilians' pay and allowances in r/o the preceding month under your audit jurisdiction starting from 5th of November, 2019. However the progress report from your office for the month of October, 2019 is still awaited.

3. It is requested to immediately forward the desired report depicting the status/progress of DBT payment for all defence civilians' pay and allowances in r/o October, 2019 under the audit jurisdiction of your office. Progress reports for the months of November, 2019 onward may be furnished to HQrs Office positively by 5th of the succeeding month.

4. Further, it is also stated that in the new system of direct credit of pay and allowances to the individual bank accounts of defence civilians, the PCDA/CDA is merely a facilitator without affecting status of the concerned unit as DDO.

Vide this HQ's office's letters cited above, all addresser Principal Controller/Controller offices had been requested to ensure that necessary action was taken for implementation of the modified TULIP system in their offices by December, 2019 for credit of pay and allowances directly to the individual bank accounts of defence civilians. It was also requested to furnish a monthly progressive report by 5th of every month indicating the status of DBT payments for all defence civilians' pay and allowances in respect of the preceding month, under the offices' audit jurisdiction.

2. As against the above instructions it is observed from the subsequent reports received from various Principal Controllers'/Controllers' offices that the above mentioned DBT payments have not been implemented by all the offices till date. The latest status of DBT payments implementation in various offices through TULIP is shown in Annexure to this letter.

3. After being apprised of the above status, the competent authority has directed that DBT payments for defence civilians in respect of pay and allowances may be fully implemented w.e.f. 01-04-2020. It is accordingly requested that necessary action to implement the payment of pay and allowances of defence civilians through TULIP may be ensured as per the above mentioned revised cutoff date.

4. It is also requested that the monthly report showing the status/progress of the abovementioned DBT payments for defence civilians' pay and allowances may be forwarded to HQ's office, as reiterated vide para 1 above.
