

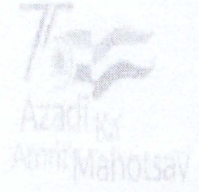


**Subject:** Non-implementation of transfer orders issued by this HQrs Office in respect of SAOs/AOs and AAOs (on promotion to AO's grade) by PCsDA/CsDA.

During the review of transfer orders of SAOs/AOs/AAOs (on promotion to AO's grade) issued by this HQrs office in the last few months revealed that considerable number of officers have not yet joined their new office of posting. This has been viewed seriously by the Higher Authorities. Therefore, the undersigned has been directed to ask the Controllers office to get all such officers relieved latest by 31.03.2023, except those who have been granted deferment beyond 31.03.2023. It is therefore, requested to take urgent action in this regard and compliance report may be sent to this HQrs office on 01.04.2023.

2. Further, it is also directed to stop payment of salary of the concerned officers who have not yet joined their new office of posting.



In this regard it is again reiterated that relieving of the officers may not be withheld on the ground that a reply to the representation submitted by the officer regarding change/cancellation/deferment of his transfer is pending from HQrs office. However, any specific case having extreme compassionate/medical ground may be referred to this HQrs office for reconsideration/review through D.O letter from PCsDA/CsDA concerned.
