**विषय /Sub: Implementation of recommendations of 7th CPC Para 11, 12,140- Grant of grade pay of Rs.5400 (PB 02)
(i.e. Level 9 of Pay Matrix in case of AAOs of Defence Accounts Department of Ministry of Defence**

Consequent upon sanction issued by GOI Ministry of Finance, Dept of Expenditure vide OM No. F No. 25-2/2017-IC/E III (II) dated 06/11/2020 circulated vide HQrs circular No. AN/XIV/14162/7th CPC/Vol-II dated 13/11/2020 approval has been accorded by the Competent Authority for grant of Non-Functional Upgradation (NFU) in respect of AAOs mentioned in Annexure A in level-9 of pay matrix of 7th CPC w.e.f. dates mentioned against their names.

2. In accordance with the ibid OM the revised pay scale of the post of Assistant Accounts Officer in the Defence Accounts Department would be in Level 8 of the Pay Matrix and Level 9 on completion of 4 years in grade pay of Rs4800 (PB-2) (Level-8).

3. In accordance with the above, approval of the Appointing Authority is hereby accorded for grant of Non-Functional Upgradation in r/o AAOs mentioned in Annexure-A (serving) in Level 9 of Pay Matrix of 7th CPC with effect from the date indicated against them.

4. This is a Non-Functional Upgradation (NFU), which is subject to the following terms and conditions.

i) The grant of NFU will be admissible on completion of 4 years of regular service in the cadre from the date of joining as AAO. The aforesaid Non-Functional Upgradation (NFU) to AAOs is effective from 01.01.2016.

ii) The NFU will be subject to vigilance clearance. The AAOs mentioned in Annexure-A to this Part II Office Order are clear from Vigilance angle.

iii) Benefit of Pay Fixation as per Rule 13 of CCS (Revised Rules) 2016 shall be available at the time of grant of Non-Functional Upgradation to AAOs. Option for pay fixation may be exercised within one month of issue of this order.


iv) After the grant of NFU to AAOs in Pay Level-9 and their pay fixation under Rule 13 CCS (RP) Rules 2016, there will be no further pay fixation on promotion to the post of Accounts Officer in Pay Level-9.

v) NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS).


