RECOMMENDATIONS

Sir,

I am directed to refer to MoD Order No. 21704/Q/ST-56/5100/D(QS) dated 12<sup>th</sup> October, 2015 and to convey the sanction of the President of India for continuation of Rs. 103.30 per man per month for Condiment Allowance till 30.06.2017. Consequent to the decision taken by Government on recommendations of the 7<sup>th</sup> CPC's after abolition of Condiment Allowance, Condiment Expenditure entitled to Defence Service personnel would be Rs. 89.78 per man per month with effect from 01.07.2017.

- 2. "The units will continue to claim 'Condiment Expenditure' as per extant procedure being followed for 'Condiment Allowance' under the existing Code Head of the 'Items of Local Purchase' under MH 110A till a new Code Head in this regard under MH 110A is opened and operationalised. The expenditure will be incurred through S&S Imprest as per extant orders".
- 3. In order to incur the Condiment Expenditure at field level, sanction is also conveyed for the following delegation:-

### Inclusion of Note below 16.1 of DFPDS-2016 in respect of Army

"The above powers would be utilised by all CFAs including equivalent CFAs of RR, JAK LI, MF and TA for 'Condiment Expenditure' under MH 110A, as per existing powers mentioned in Schedule 16 for procurement of condiments".

- 4. The above changes will also be applicable to Indian Air Force and Indian Navy.
- 5. This issues with the concurrence Ministry of Defence (Finance) vide ID No. 14(1)/2000/QS/276 dated  $22^{nd}$  Dec 2017.
