

Subject: Concurrence of CDA for Board Proceedings of Provision of Service Transport for school going children at Military Stations

Of late, it has been noticed that cases for running of Service transport for school going children are processed during the currency of the school academic year (and in most cases, even after the proposed service transports are put to service at the start of academic session) and sent to this office for concurrence of CDA which is in contravention to Govt. order in force & AI 15/87. The ibid AI stipulates that Concurrence of the CDA should be obtained before the academic session begins or the school buses are put to service.

The irregularities are adversely commented by our HQrs office during their recent inspection of this office and needs to regularise such cases by obtaining sanction from authority as provided in Regulation – 178 of FR – Part I Vol- 1.

It is therefore requested that all future proposal for detailment of Service Transport for school going children should be submitted to this office well in advance of the academic year for prior concurrence of CDA.
