- Correct carry forward to the Top Sheet;
- Checking that all answers are evaluated;
- Rectification of other errors and omissions;
- Revaluation does not mean remarking of the answers.

Intending candidates may submit their applications as per enclosed proforma within the stipulated time limit after fulfilling the conditions laid down in Rule 19 of the SAS Rules so as to reach this section latest by **21<sup>st</sup> OCTOBER, 2016**. A candidate must have got at least 30% of marks in the paper(s) for which he/she desires revaluation. **An application preferred beyond the time limit and which does not fulfill the requisite conditions for revaluation shall not be entertained in any way.**
