Intending candidate may submit their applications as per enclosed proforms within the stipulated time limit after fulfilling the conditions laid down in Rules 19 of the SAS Rules so as to reach this section latest by 17th November, 2017. A candidate must have got at least 30% of marks in the paper(s) for which he/she desires revaluation. An application preferred beyond the time lime and which does not fulfill the requisite conditions for revaluation shall not be entertained in any way.
