It may be clarified that as per decision of MoD (Fin), withdrawal of a candidate of medical ground was removed when the scheme of examination was revised during 2007. As such failure to appear in this examination by way of absenteeism on Medical ground and request submitted after time limit specified in SAS Rules will entail forfeiture of one of the four valuable chances allowed to candidates as per revised SAS Rules. It is clarified that under no circumstances request for withdrawal in respect of candidates availing special chance will be accepted.
