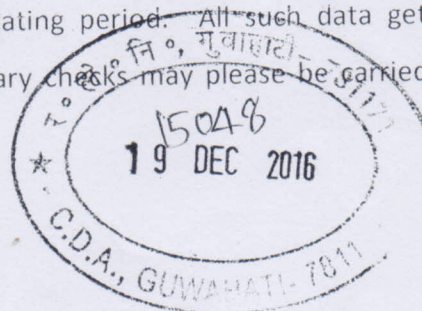
Dear Hangzo,

I am writing this in connection with the timely uploading of correct data by the AAOs BSOs through Project Bhawan, pertaining to recovery of rent and allied charges of Army Officers.

2. HQ Office vide Important Circular No Mech/EDP/AAO BSO dated 23 March 2012, had issued instructions that Rent/ Licence Fee and other charges, Occupation/Vacation Reports are to be forwarded in a soft copy through project 'BHAWAN'.

3. In this respect, it has been noticed that there is considerable delay in forwarding of the online vacation reports through Project "Bhawan" by various AAOs, BSOs leading to grievances from the Army Officers due to continued deduction of rent for old duty station. The quarterly bills for water and electricity charges are also not being forwarded in a timely and phased manner. Bills for two or more quarters are being clubbed and forwarded at a time. This results in bulk recovery, and consequently grievances from the Army Officers. A number of complaints are also received from the Army Officers on account of double recoveries of rent and allied charges for the same period due to multiple uploading of the files by the AAOs, BSOs.


4. In many cases, the online bills are received quoting incorrect particulars of Army Officers like incorrect CDA A/C number, incorrect personal number etc. In some cases refund bills are received without indicating period. All such data get rejected for re-submission. I would request that all necessary checks may please be carried out to avoid rejections and consequent delays.



5. I request that necessary instructions may please be issued to AAOs, BSOs under your administrative control for addressing above deficiencies at the level of AAOs, BSOs. I shall be grateful for a line in confirmation of action taken which will ensure error free transmission of online data relating to rent and allied charges, and avoid grievance of the Army Officers in this regard.
