## Subject:- Posting of Volunteers to Bhutan: AAOs/SO(A)

It has been decided by the HQrs Office, New Delhi vide their letter No.AN/IX/9010/Bhutan Panel/2015-16 dated 27/07/2015 to call for Volunteers amongst AAOs/SO(A) for posting to Bhutan.

While forwarding the names of volunteers, it may kindly be ensured that the following criterias are strictly kept in view and only those names who fulfill the criteria are forwarded to this office:-

1) The applicants are eligible for only one tenure to Bhutan in the entire service career, irrespective of grades served;
2) They should not be facing any disciplinary proceedings and they should not have earned any penalty, including recorded warning at any time in their career:
3) They should have completed a period of three years after their last sensitive assignment as on 27/07/2015;
4) The applicants need to have 'Very Good' or above grading in the ACRs/APARs for the last five years;
5) They should have rendered at least two years service in the AAO's grade as on 27/07/2015
6) The applicants should be left with minimum three years of service as on $27 / 07 / 2015$ before their date of superannuation
