In continuation to this office earlier Circulars dated 18.10.2016 and 17.11.2016 the following changes have been made in e-mpr module:-

- (i) Two new fields viz "RTI cases" and "Complaints Cases" have been added, status on which is to be provided in e-mpr module from the report of January, 2017 onwards,
- (ii) Against each item of report a "Remarks" column has been added for furnishing reasons and breakup of claims pending for more than 30 days.
- 3. It has been noticed that controllers are not adhering to the time schedule for forwarding e-mpr i.e. by 2<sup>nd</sup> working day of the month sighting reasons viz. non availability of CDA Administrator/Approver/Checker/Uploader being on Ty-Duty/Leave/Transfer etc. It is enjoined upon Controllers to ensure timely rendition of report by creating alternative User-IDs on temporary basis, as per SOP already forwarded.
