Registration of DDO's under Section 51 and 52 of GST Act.

\*\*\*\*\*\*

In terms of Section 51 and 52 of GST Act, persons (DDOs) who are responsible for deduction of Tax at source (under Section 51 of GST Act) and collection of Tax at source (under Section 52 of GST Act) will be required to be registered, but the liability to deduct/collect Tax will arise from the date of the applicability of the respective Sections as may be decided by the GST Council in due course.

Registration will have to be done as per Section 22-24 of GST Act. As per Section 25(6) for registration, valid PAN/TAN No. is mandatory and Form GST REG-07 may be used for the purpose.

Detailed instruction are available on CBEC website i.e. cbec.gov.in.

In view of the above it is directed to liaise with GE and advise them to take necessary registration under Section 51 and 52 of GST Act, if not yet registered.

It is also requested to obtain the DDO registration Number from your GE and forward the same to this office for necessary action at this end.
