- 2. CENTRAD vide letter no. TD/3370/AAOs/2021-22 dated 11.06.2021 has forwarded the Revised Standard Operation Procedure of Training Institutions for containment of Covid-19 which has been issued by DoPT. Keeping in view of the aforesaid SOP, the Induction Course for newly promoted AAOs will be conducted in two separate batches.
- 3. The induction course for the first batch of newly promoted AAOs will be held <u>from 23-08-2021 to 04-09-2021</u>. The nominated names of the participants which have been included in the 1st batch is placed at Annexure 'A' w.r.t. Controller wise available slots. Remaining participants will be accommodated during the 2nd batch to be conducted subsequently.
- 4. It is stated that the candidates selected for the course will be provided accommodation at RTC Kolkata maintaining DOPT guidelines. All participants, thus nominated will have to compulsorily stay at RTC accommodation as per the requirement of the course designed by HQrs. office. No request for own arrangements may be allowed in this regard.
- 5. The nominated participants will mandatory possess report of RTPCR Test carried out 48 Hours before coming to RTC (ER) Kolkata and will also have their permanent ID Card ,Release letter from respective office(s) and Vaccination Certificate(s).
