## SUBJECT: QUARTERLY UPDATE ON PAOS PERFORMANCE.

In the quarterly update/status on PAOs performance received vide NSDL letter No. AS/MK/BD/201690690 dated- 18.07.2016.

- 1. REJECTION OF SCF IN NPSCAN: Subscriber Contribution File (SCF) uploaded by the Nodal office may get rejected due to various reasons. The list of PAOs/CDDO with rejected SCFs in the month of October 2015 has been enclosed as Annexure AU-14. You are therefore requested to verify whether correct SCF is uploaded subsequently against these rejected files and to ensure that SCFs are correctly uploaded henceforth.
- 2. CREDIT ANALYSIS: (Annexure QU6 and QU7) To ascertain regularity of contribution upload by Nodal Offices, analysis has been conducted of the contribution credits received by the subscribers (PRANs generated till JUNE 30, 2016) during the past 12 months. Ideally all NPS subscribers should have received at least 10 credits till May 31, 2016. This analysis excludes arrear contribution. During the analysis it has been observed that 64 PRANs have not received a single credit for the past 12 months.
- **3. ZERO BALANCE PRANS:** This analysis reveals that there are subscribers who have not received a single contribution till date (regular+arrear) since the date of PRAN generation. A PAO wise list of such subscribers is enclosed as **Annexure QU2** You are therefore advised to look into these cases for timely credit to the subscribers account.
- **4. WITHDRAWAL STATUS UPDATE**: As per NSDL ibid letter, eight request of withdrawal is still lying pending under your jurisdiction which is annexed as ANNEXURE-AU1. Therefore, you are requested to provide the requisite documents as given in **ANNEXURE-AU1** to CRA at the earliest to clear the case. In this connection, MO CDA Guwahati letter no. DDP/I/NPS/18/ORDER/VOL- XXI dated- 26.06.2014 also refers in which clear guidelines on account of withdrawal ( death/resignation ) has been given.

5. PENDING WITHDRAWAL INITIATION (SUPERANNUATION CASES) ANNEXURE- AU12: CRA system generates the 'Claim ID' six months prior to the date of subscriber's superannuation. Claim Id is communicated to the subscribers through letter, email and sms for initiating the withdrawal request. You are therefore advised to complete necessary formalities and initiate withdrawal at the earliest.

A feedback report may be forwarded to this office and you are further advised to utilize the various functionalities provided in the NPSCAN system in order to minimize the grievance raised by the subscribers and aid in effective monitoring at this end.
