Subject: Functioning of RTI online webportal viz www.rtionline.gov.in/RTIMIS.

It is intimated that the issue of updation of DPIO in such a manner that it is mapped with the concerned CPIO and updation of RTI applications received offline to RTI online portal in easier way has been taken up with RTI-PMU. However, the following points are requested for compliance till the issues are resolved with DoP&T (RTI-PMU):

- (a) All FAAs/CPIOs are requested to send the details (viz. Office name, Phone number, E-mail id etc) of their concerned DPIOs i.e. custodian of information located at other station than CPIOs/FAAs. The user id and password then accordingly will be created and intimated to concerned CPIOs with request to forward that to concerned DPIOs.
- (b) It is requested to upload offline applications/requests on RTI online web portal within 5 days of receipt of the same. Each CPIOs will have to open the portal with their provided user id and password and under the utility tab the column lodge request will be updated. On updation of lodge request the offline application will be converted as online application and then their disposal can be handled as disposal of online application.
- (c) It is also requested for discontinuance of monthly progress report from CPIOs. However, the Quarterly RTI Report may be submitted on this office E-mail Id <u>adminopio.dad@liub.nic.in</u>.
