As per SAS Rule 14(b), each permission to appear in SAS Part I or Part II examination will count as one chance against the respective part, whether he/she actually sits for the examination or not unless he/she is specifically allowed to withdraw his/her name by the CGDA. In accordance with the ibid proviso read with SAS Rule 14 (d) withdrawal of the candidate not submitted within laid down time period would count as a chance. It may be clarified that as per decision of MoD (Fin), withdrawal of a candidate on medical ground was removed when the scheme of examination was revised during 2007. As such failure to appear in this examination by way of absenteeism on medical ground and request submitted after time limit specified in SAS Rules will entail forfeiture of one of the four valuable chances allowed to candidates as per revised SAS Rules. It is clarified that under no circumstances request for withdrawal in respect of candidates availing special chance will be accepted.

4. Further in order to ensure transparency and fair conduct of Examination, the Competent Authority has decided to Video-graph (with audio) the entire proceedings of the Examination during all the five papers. This may please be brought to the notice of all candidates.

Reference: In continuation of this HQrs. Office Most Important Circular No. AN/SAS/16102/ SAS -II/Dec./2016/PROG. dated: 15.09 2016.

A Booklet containing names of the candidates who have been permitted to appear in SAS Part-II Examination scheduled to be held from 12th to 17th December 2016, indicating Roll Numbers allotted to them and the Stations/Centres at which they are to appear in the examination showing Centre Code Number is uploaded on CGDA's Website for further necessary action. No hard copy of Roll Nos. will be sent separately.

2. Due to administrative reasons it has been decided by the Competent Authority to conduct the Examination at 18 centres only. PCsDA/CsDA are requested to provide accommodation for outstation candidates if available, on request. The candidates who have opted for appearing in the centres other than the nearest centres to their duty station at their own request/recommended by PCsDA/CsDA would not be entitled for traveling allowance. The change of centres on personal ground shall not be accepted in any case.

3. List of centre-wise roll numbers is also enclosed. Corrections, if any, specially in Name /Grade/Account No/Category/Centre/Section/Hindi option/Exemption/chances etc. may be verified scrupulously and informed immediately to this HQrs. Office for carrying out necessary amendment thereon.

4. Necessary information may be sent to those centres as well as to the concerned PCsDA/CsDA well in advance in respect to those candidates, who may be appearing from centres other than those falling under your jurisdiction, since any delay in this issue, will adversely affect the prospective candidates.

5. As per SAS Rule 14(b) each permission to appear in SAS Part I or Part II examination will count as one chance against the respective part, whether he/she actually sits for the examination or not unless he/she is specifically allowed to withdraw his/her name by the CGDA. In accordance with the ibid proviso read with SAS Rule 14 (d) withdrawal of the candidate not submitted within laid down time period would count as a chance. It may be clarified that as per decision of MoD(Fin), withdrawal of a candidate on medical ground was removed when the scheme of examination was revised during 2007. As such failure to appear in this examination by way of absenteeism on medical ground and request submitted after time limit specified in SAS Rules will entail forfeiture of one of the four valuable chances allowed to candidates as per revised SAS Rules. The no's of chances availed by the candidates have also accordingly been mentioned in remarks column against each candidates. **It may further be clarified that under no circumstances request for withdrawal in respect of candidates availing special chance will be accepted.** This may be brought to notice of all the candidates.

6. Further in order to ensure transparency & fair conduct of Examination, it has been decided by the Competent Authority to Video-graph the entire proceedings of the Examination during all five papers. The instruction in this regard is being sent separately to the Conducting Officers of all Examination Centres. This may also be brought to notice of all the candidates.

7. Printed Answer Books/Continuation Sheets in respect of each Paper i.e. Paper-V, VI, VII, VIII & IX shall be supplied from the HQrs. Office. The Conducting Officers of the Examination Centres have to ensure the following in respect of Practical Portion of Paper-IX - Fundamentals of EDP :-


- (a) To make available a workable P.C. fitted with necessary software installed and necessary accessories to each candidate in the examination hall.
- (b) To supply of a good quality CD to each candidate with necessary packing guard.
- (c) To take an additional copy of each candidate's answers on a PC to be kept safe under their personal custody till further orders from HQrs office.
- (d) To keep answers of each candidate in a CD as a back-up to be sent to HQrs office along with Answer Books. The extra back-up taken, shall have to be disposed of after hearing from the HQrs. Office.

The detailed instructions for the above Examination shall be made available as Annexure-I. Instructions for conducting SAS Part-II Examination December, 2016 which will be sent separately.

8. Since the number of candidates appearing from each examination centre is now available, the Conducting Officers should ensure in time, availability of PCs in the examination hall for smooth conduct of Paper-IX-EDP (Practical Portion) of above examination.

9. The list of SC/ST candidates may please be furnished to this office as per instructions contained at Para-7 of our Most Important Circular No. AN/SAS/16102/SAS-II/DEC./2016/PROG. dated 15/09/2016. The list if not sent, may now be prepared independently after verifying their service books and not based on the information furnished by the candidate(s). It may also be certified that the list furnished is with reference to the information recorded in the Service Books of the candidates concerned. The same may be sent by SPEED POST so as to reach this HQrs. Office by 25th November, 2016.
